ELIGIBILITY

Buxhall Village Hall was brought into being by Trust Deed dated 10 August 1962.

- (1) *No one under the age of 18 years may be a member of the management Committee;*

Clauses 7, 8 and 9 established by the Trust Deed lists persons ineligible to be members of the management committee and these sections are set out below:

- (2) *Clause (7) states: No person shall be entitled to act as a member of the Committee whether on a first or any subsequent entry into office, until after signing the minute book of the Committee a declaration of acceptance and willingness to act in the trusts of this deed:*
- (3) *Clause (8) states: Except with the approval in writing of the Minister of Education, no member of the Committee or his or her spouse, shall take or hold any interest in property belonging to the Foundation, otherwise than as a trustee for the purpose thereof, or receive any remuneration, or be interested in the supply of work or goods, at the cost of the foundation;*
- (4) *Clause (9) states: Any Member who is adjudged bankrupt or who makes a composition or arrangement with creditors, or who is incapacitated from acting or who communicates in writing to the Committee a wish to resign, shall thereupon cease to be member; furthermore:*
- (5) *Subject to paragraph (9) a person shall be disqualified from holding, or from continuing to hold, office as a member, if that person has been adjudged bankrupt, or is the subject of a bankruptcy restrictions order, an interim bankruptcy restrictions order or a bankruptcy restrictions undertaking within the meaning of the Insolvency Act 1986.*
- (6) *Where a person is disqualified by reason of having been adjudged bankrupt or by reason of being the subject of a bankruptcy restrictions order, an interim bankruptcy restrictions order or a bankruptcy restrictions undertaking, that disqualification shall cease—*
 - (a) *on that person's discharge from bankruptcy, unless the bankruptcy order has before then been annulled; or*
 - (b) *if the bankruptcy order is annulled, at the date of that annulment; or*
 - (c) *if the bankruptcy restrictions order is rescinded as a result of an application under section 375 of the Insolvency Act 1986, on the date so ordered by the court; or*
 - (d) *if the interim bankruptcy restrictions order is discharged by the court, on the date of that discharge; or*
 - (e) *if the bankruptcy restrictions undertaking is annulled, at the date of that annulment.*
