Review of Suffolk County Council Boundaries – public consultation

The Boundary Commission have now announced that they will be looking to reduce the number of councillors at Suffolk County Council from 75 to 70. The next stage of the process is to determine where the division boundaries should be. There is a public consultation which will run until 2 December 2019, available here: https://consultation.lgbce.org.uk/node/18495

I believe you were invited to a meeting with them at Endeavour house

My group consider there should be no reduction due to the increase in the number of planning permissions and therefore electors.

New process for requesting speed limit changes

There is now a new process in place for requesting speed limit changes. The local county councillor must act as a "filter": all requests for changes need to come through them, and any individual or parish council who requests a change will be referred to the local councillor. The local councillor will need to persuade the officer group to support a request for a speed limit change. The group will then produce a report on the pros and cons, which the local councillor can comment on before the report goes to Cllr Mary Evans (Cabinet Member for Highways) for a final decision.

REDUCTION IN HEALTH VISITORS; I am putting a motion to the council next week asking that the council re-instates the number of health visitors as there is a crisis in the current number having to cope

Sizewell C – response to Stage 4 Consultation

On 24 September, the Cabinet agreed a response to EDF's Stage 4 consultation for Sizewell C. The Cabinet maintains that they support the principle of nuclear technology, but do not currently have sufficient information to support the proposals for Sizewell C.

My group (made up of Liberal Democrat, Green and Independent councillors) at the county council has called on the Cabinet to reject EDF's proposals for Sizewell C. Our concerns include:

- EDF will be overcharging UK consumers for electricity from Sizewell for the next 35 years.
- Impact on the surrounding natural environment, including the Suffolk Coast and Heaths AONB;
- Impact on the tourism industry;
- Additional carbon emissions and congestion from a road-led strategy;
- Lack of planning for nuclear waste disposal;
- Unsympathetic design to the surrounding natural area;

- Additional pylons in an already crowded landscape;
- Not convinced by EDF's economic development argument.
 Interestingly just a day after the cabinet meeting EDF announced that Hinckley point was vastly over budget and over time

HOME TO SCHOOL TRANSPORT.

There are still numerous pupils waiting for their bus pass, some have been given tempory ones, I am asking how many appeals have taken place and how many have been successful. Some of these will be officer decisions but many will go to the transport appeals panel,

I have been on a walk for an appeal from Onehouse but feel it would be difficult for parents to use footpaths during poor weather.

I will be asking the cabinet member how he can justify the unmitigated disaster not just in PR terms but the awful impact on families.

FOOTPATH FROM FOREST ROAD; I have reported the state of the path which is part of the diversion.

MOTION TO INCREASE TREE COVER; this was to work with councils to increase community woods and orchards, support tree wardens, allow re-wilding and be included in neighbour hood plans. I asked that the council must be more active in allowing tree preservation orders.

PLANNING; I have advised the applicants for the land at south on Mill Road which has now been refused.

NEEDHAM LAKE VISITOR CENTRE; finance has been approved and the council will be looking for someone to take over the running. Planning permission will be applied for.
